From the President

"The 'Nones"



For several years now, "The 'Nones'" have been written about in many publications. These articles referred to something we all are painfully aware of: Namely, most organized religion is losing membership/participation. So what can we do as a Reform Jewish congregation to stop or slow the slide of people away from us? Understand that this is

a separate (but related) question as to how do we attract NEW congregants.

First, we need to understand that Nones are not of a particular age group; Nor do they have similar backgrounds in education, wealth, or most readily definable common denominators. Some are active in social causes, some are not.

If religious organizations are going to thrive in the future, all must find the means to attract these Nones to them - or - back to them. This includes Temple Israel of New Rochelle. This isn't necessarily a dire prediction, but one we must thoughtfully think through. Our thinking of what attracts and keeps future members must be constantly re-evaluated.

Over the next several months, I intend to gather a group of congregants who are willing and able to ask tough questions not just of ourselves but of those who have chosen to non-affiliate. I'll ask the group to, initially, come up with questions, more than answers. I hope that as we begin to re-evaluate who we are, that maybe, just maybe, we are willing to alter some part of our future course that will both enable ourselves to not only maintain our current identity, but expand it so that the Nones might be at least willing to consider to re-establish ties with organized religion, and TINR in particular.

Like those of many congregations, Temple Israel's future depends on our ability to envision the future home of our families culturally, socially, and spiritually. Board of Trustees Meeting Minutes Wednesday, September 22, 2021

The financial report highlight was that Temple Israel has a surplus from the camp and operating surplus will be returned to the endowment. Rabbi Jesse explained that the surplus was a combination of lower costs and higher revenues than were expected. The Board thanked Jesse for a successful summer with no COVID cases and happy campers.

The Executive Director reported that membership has declined this year and that these changes are being discussed. We will continue a healthy discussion to address these changes. The Board voted on 19 resignations and 10 new member units. Other synagogues are experiencing similar decline due to COVID and TINR will continue to monitor and address these changes. We will be looking at programing to address the lingering effects of COVID and to start small programs such as Brotherhood Bourbon & Bible.

Rabbi Jay's words of inspiration reflected on the remarkable members of TINR, the professionalism of Cantor Schloss and Rebecca Elkus-Ferst that is unsurpassed and how Anita is the glue that keeps us together. He highlighted Social Action's work to help get a mother and her children out of Afghanistan. He also commented on the impressive programs, such as that for Chavaya. He added, "This is a remarkable temple. A sense of security and stability will come...I hope the congregants will be as proud of me as I am proud to be their rabbi."

Brian also explained that emergency expenses were incurred due to remnants of Ida. The basement classrooms and storage needed to be cleaned to avoid mold and further damage. The work was satisfactorily completed. An application has been sent to receive remuneration from FEMA.

He also reminded the board that everyone received their request for pledge commitments, and that almost all active board members have made their pledges. He urged all temple members to give what they can and to also pay membership dues in whatever amount is possible.

Brian announced that Liz Weingast will address revisiting

the mission statement and a vision statement to create something new.

Brian reported on the High Holidays services in the tent and that the services were very well received. Comments from congregants were overwhelmingly favorable.

Temple Israel Cares, as part of the High Holidays Appeal, received \$1,800.

Rabbi's Note

As We Welcome Thanksgiving and Chanukah...



Our holiday of Chanukah provides us with lessons to take to heart as we encounter the New Year. It has been said that the world is warmer and brighter between December and January than it is between January and December. The reasons are obvious. December is the month of giving and of religious and secular celebrations. For World Jewry, it is

the time of the year when we celebrate Chanukah, our joyous holiday of lights. In fact, this year, no sooner will we have finished eating the Thanksgiving leftovers, on Black Friday, we begin our quest for those perfect gifts for our children and grandchildren. The joy of giving and the reward of seeing happy children as they unwrap their gifts is the essential theme of Chanukah. That being said, let us not lose sight of the main message of our festival of lights as reflected in the central personalities of the Chanukah saga, the Maccabees. In addition to transmitting a message of heroism, their valiant war against tyranny, seemingly against insurmountable odds, provides us with direction in addressing the challenges of our day.

The first lesson we learn is resolve and commitment to cause. This is a most important lesson as American Jews are facing an unprecedented rise in anti-Semitism. The most recent audit of anti-Semitic incidents in the United States by the ADL, recorded more than 2,100 acts of assault, vandalism, and harassment, an increase of 12 percent over the previous year. This is the greatest number of anti-Semitic incidents since the ADL began tracking these heinous occurrences in 1979. This year's statistic is comprised of five fatalities, and ninety-one physical assaults against Jews. Furthermore, since the 2018 ADL report on anti-Semitism and social media showed that there were 4.2 million anti-Semitic tweets were shared and re-shared on Twitter over a twelve-month period, I have no doubt, given the unprecedented upswing in anti-Semitic assaults of every kind, that the number has increased exponentially.

Just as the ADL is tracking each of these incidents, closer to home, the UJA-Federation of New York has dedicated significant resources to securing our synagogues and other Jewish institutions. While this can and does provide us with a sense of security, it is a tragic fact that we must devote communal resources to ensure our day to day safety. But let us take heart in knowing that we are not helpless; that the status quo need not be accepted nor a portent for the future. We must not only rely upon our Jewish organizations and elected officials, but we as congregations and as individuals must take steps on our own to change the present environment. Let us begin by confronting hate with love, despair with hope and prejudice by promoting understanding and respect. Most importantly, we must build bridges of understanding between the diverse members of our

community and be champions in the cause of Jewish unity. The second lesson of the Maccabees to take to heart is keeping faith with ourselves, most especially when we encounter setbacks, obstacles, and reverses in life. Remember, the Maccabees, in addition to their victories, had their defeats. Yet, they stayed the course and won the day.

Finally, the Maccabees teach us the importance of having faith in God and expressing that faith in one's daily life. We at Temple Israel are blessed with a spiritual home that reflects our connection to the glorious odyssey and indelible imprint of the Jewish people, who have written and transformed world history for the better. Added to that, is the *neshama* – our collective soul – enriched one by the other, which connects us to the Holy One we call Adonai. As the Maccabees were one family, united in a common cause, so too do we stand united as one Temple Israel family, committed to our present and building for the future. The Maccabees' first act after winning the war against Antiochus IV was rededicating the Temple and rekindling the Menorah, symbolizing hope, life, and faith in God as God's Eternal People, a light unto the nations of the World.

On behalf of my family and myself, from our home to yours, from heart to heart, we wish you a New Year of health, happiness and fulfillment. A New Year in which we are armed with the courage, resolve, and faith of the Maccabees, and where we bring the light of love and warmth into our homes, community, and nation dispelling the darkness of the past. A New Year when God bestows upon us his choicest blessings and upon all his children, the gift of Peace.

Cantor's Note

Connecting Chanukah with Thanksgiving



Way back in 2013, you may remember that we celebrated "Thanksgivukah," with Chanukah falling so early that year that it coincided with American Thanksgiving. Actually Thanksgiving most closely resembles our holiday of Sukkot, but I digress! I am grateful that the Jewish calendar will never be so completely out of sync with the secular

calendar to allow for Sukkot and Thanksgiving to align. In any case, this year we don't quite have "Thanksgivukah," but almost. Chanukah begins just a few days after Thanksgiving, on the Sunday evening of Thanksgiving weekend. Remember that Rosh Hashanah began on Labor day?

If we are to celebrate Chanukah, at least during the Thanksgiving weekend, what are some possible connections? Or perhaps we can ask the more general question that the Rabbis of the Talmud ask, seemingly out of nowhere: "What is Chanukah, anyway?"

Like so many of our Jewish traditions, we have multiple sources, multiple versions. Starting right at the beginning of Torah with the story of creation, we are given a straightforward creation story. "On the first day God created light and darkness...." And then we immediately have another story of creation, very different in focus and character. Similarly, the Passover story found in the Hagadah differs greatly from the story told in Torah. Many details are similar, but there is one primary difference: In Torah, Moses is the protagonist, the hero. Moses leads his people to freedom. In the Hagadah, there is hardly a mention of Moses. Instead, God's role is highlighted. God redeems Israel and Moses' role is minimized.

The history of Chanukah contains a similar dichotomy. The earliest source for Chanukah, the apocryphal books of Maccabees I and II, tell us of the heroics of the Maccabees, the power of the Hasmonean dynasty. The heroes are real people, those who fought for their rights to practice their religion in the face of Greek oppressors. The Talmud, answering their general question of what Chanukah is all about, tells us a new story of the miracle of the oil: how one cruse of oil which should have lasted only one day, lasted for eight days, allowing for the light to remain lit in the destroyed Temple. It is truly a miracle from God.

Which brings us back to my original question: how can we connect Chanukah with Thanksgiving? For what or whom are we grateful? Do we thank God as the Rabbis of the Talmud suggest? Or should we remember the heroics and learn the lesson of a strong people who stood up for their beliefs despite the challenges? In true Reform tradition, I would suggest both. Judaism is truly a *brit* — a covenant. God and the Jewish people are partners, each doing their part toward *tikkun olam*, the repair of the world. Traditional Jews, the ultra-orthodox,

wait for the coming of the Messiah when the world will become a paradise. In Reform Judaism, we do not wait for the Messiah to come: through our own acts of tz'dakah and g'milut chasadim (righteous acts), we partner with God and actively work to bring the messianic age to our world.

So this Chanukah, we can certainly be grateful for God's power in our lives. We celebrate God's miracles through beautiful traditions of lighting the menorah, eating latkes and singing joyous music. We also remember the great power and heroism of real people in our history, and we continue their work today and every day. I am grateful that our tradition inspires us to act.

Temple Israel Cares has sent Welcome Kits to new members, assisted those in need due to the remnants of Tropical Storm Ida, and distributed 12 shiva bags and 4 baby blankets. Toni Hoffman and Berdie Stein thanked all of those who have helped.

Brian reiterated that it is imperative that we act as a family; if you see someone in need, tell someone, don't assume it is known.

New interim Board members: Amy Ecker and Sharon Gorman were unanimously approved to serve out the terms of two members that resigned.

Committee Reports: Paul Warhit, on behalf of the Israel Action Committee, submitted a report to the board as required, and Howard Horowitz will submit his report of the Advocacy Committee next month.

COVID Taskforce: Marilyn Morris chair of the COVID Taskforce, explained that for the High Holidays, the COVID Taskforce unanimously decided on advising for masking outdoors since we would be in large numbers, close proximity, and singing. The Taskforce still advises masking indoors. They also advise that proof of vaccines was not required outside of High Holidays' large gatherings. At the moment, the Taskforce in regards to activities outdoors, does not have a recommendation for or against masking.

The Board voted to continue the masking requirements for indoor activities per the taskforce's advice.

Brian Heaps discussed that in the past the *tzedakah* box in the temple lobby was to be used by the Social Action Committee. He proposed that the funds be shared by both Social Action and Temple Israel Cares. Both could determine how those funds are used. The vote was unanimously approved.

Sharon Gorman was unanimously approved as the new Membership Committee Chair.

The Board will also be working on ways to reach out to congregants.

Good and Welfare: With the help of Rabbi Jay and others, a brother and wife of a new American, were able to get out of Afghanistan. Congratulations to Rebecca Elkus-Ferst and the very successful apple picking event during the Second Day of Rosh Hashanah.

Board of Trustees Meeting Minutes Wednesday, October 20, 2021

The rabbi began with an inspirational message that we pray God inspire us and that we feel the presence of the Holy One within us.

Adam Egelberg presented the Treasurer's report and was pleased to announce that we are \$240,000 ahead of budget. A successful camp season and an anonymous donation account for the surplus.

Adam presented a revised 2022 budget showing that we are moving from deficit to surplus. The underlying financial support for Temple Israel has turned around. We are pacing ahead of last year in donations, especially since Temple Israel Cares and Social Action committee actions during COVID were much appreciated.

The projected surplus is \$136,593 and according to decisions last year will be repaid to the endowment.

The board unanimously approved acceptance of a directed gift which included:

\$60,000 to fix up entrance driveway to synagogue \$10,000 for a study to put up a sound barrier fence \$15,000 to offset tent rentals

Executive director Anita Aronoff acknowledged the significance and joy that this was the first board meeting where all attendees were in the building together. At this time 76% of pledge commitments are in, and by December usually 90% are submitted. We are on track to get to 90% by December; moving in same trajectory as we have done in the past.

Anita also stated that clergy and staff will continue outreach in conjunction with the membership committee and its new chair, Sharon Gorman.

The High Holiday appeal brought in \$13,000, not including the funds donated to Temple Israel Cares. The temple was not planning on receiving funds from guest tickets since we were not sure we'd have services in person, but in the end we received more revenue on guest tickets than expected.

Temple also came in \$13,000 over budget for the High holidays.

President Brian Heaps circulated signup sheets for Board member representation at Bnai mitzvahs. As board members it

is important that we share in these celebrations and welcome guests to the temple.

Brian also reiterated that membership is also about getting people involved in our community and he shared a news article about "The Nones"—why people are not affiliated with religious organizations and their need to for civic and social engagement in its place. He discussed the need for greater inclusion, which is being addressed in the diversity and Inclusion committee and to plan for the future of membership five to ten years from now.

On November 12, Rabbi Jay has secured David Gill from the German Consulate to speak on the anniversary of Kristallnacht. David Gill is a senior official that has been a strong ally heading the Jewish desk in Germany and served as chief of staff to the President of Germany.

Committee Reports:

Toni Hoffman delivered the Temple Israel Cares report and stated that the committee consists of 12 TINR members and that they continue to deliver gift bags to new members, shiva bags and baby blankets to our newest members.

Laurie Dubner gave the camp report and explained that Camp Pinebrook is seeking to host four Shlichim, which means "emissaries", from Israel to work as camp counselors. This was done three years ago and it was a resounding success. We are looking for families to host them providing room and board. Families would only need to host one, not all four. Those that have hosted before only had positive things to say about the experience. Please let Rabbi Jesse or Laurie know if you are interested.

Ilissa Warhit was unanimously approved as the new co-chair of the Advocacy Committee

The Board also voted on a new policy utilizing the Covid Taskforce's latest recommendation. The board voted on a final proposal which was "Permission for vaccinated adults to unmask when engaging in food and drink during indoor events when in closed spaces where children are not present or permitted." The synagogue will follow this policy and the Covid Taskforce will continue to monitor the situation and continue to provide guidance. The pandemic is constantly evolving and we will continue to revisit our Covid protocols.





The "Better Together™" Program



Jewish scholars and texts have been commenting on the proper treatment of older adults since biblical times: "Do not cast me aside in old age, when my strength fails, do not abandon me" (Psalm 71:9). Moreover, there is a great emphasis and deep commitment at Temple Israel, to respect the dignity of the older members of our community.

Turkeys ... and Menorahs!





New Specialty Programming at Camp!



As you know, Camp Pinebrook had a hugely successful summer. Camp is creating a culture of living Jewish values that make for a great community. As the premiere Reform day camp of Westchester, we work with URJ overnight camps, helping to connect our alum with Crane Lake and Eisner Camps. While some of our campers move on to overnight camp, others are less interested. This summer we had 17 campers in

our oldest group. And after four years, we had youth graduating from our program. Therefore, we have decided to expand our program and go up through age 10 (5th grade).

To strengthen our programming for elementary aged campers, Camp Pinebrook will be adding more specialty programs. It is our goal to offer ceramics, glass art/jewelry making, gymnastics, and tennis to our repertoire. With older campers, we would like to also offer electives. Normally campers go to all activities with their bunks, which are about 30 minutes. This works well for younger campers. But now, 2nd-5th grade campers will have the opportunity to choose a special in-depth activity for most of the

afternoon. This allows an activity specialist to really explore concepts and skills with the older youth.

For example, instead of a simple cooking activity, children can learn to bake from scratch or prepare a meal. With sports, coaches can come and offer clinics helping our campers gain the skills needed to be proficient or reach the next level in their desired sport. Camp Pinebrook is looking at innovative ways to fully engage our youth as we grow.

Please continue to spread the word about camp. We are offering early registration discounts through January 15th. Camp Pinebrook offers a first-time camper grant, and all members of the congregation receive a \$500 family discount. 





ICNAW Update

(Interfaith Council of New Americans Westchester)

Dear Supporters of the Interfaith Council of New Americans Westchester (ICNAW):

Our third quarter could have been a scene from The Raiders of the Lost Ark. The chaotic exit of American forces from Kabul in late August had direct and dramatic consequences for the Ghafoor family living here in White Plains. In late June, Mahnaz and her two youngest children traveled to Herat to see her ailing mother. When the Taliban occupied the city in early August, they were trapped in the crossfire. A relative bundled Mahnaz into a burqa, and drove them all through the night, past multiple Taliban checkpoints. They arrived in Kabul just as the Taliban was closing access to the city. Then our network got to work, calling contacts in Congress, the State Department, the Pentagon, and the American Embassy in Kabul. In late August, Mahnaz and her children were evacuated to Qatar, and then to Dulles Airport.

In parallel with those efforts, the ICNAW worked feverishly to evacuate Farhad Ghafoor and his family. Farhad worked as interpreter for the U.S. military, and is the third brother of Fardin and Haroon, who along with their families have been resettled in White Plains by the ICNAW. Working with two lawyers at Dana & Wiggins and a U.S. Army Special Ops contact in Kabul, we helped them reach Qatar. If all goes well, Farhad and his family should be allowed in the United States under SIV status by the end of October.

How You Can Help Afghan Refugees

There are about 10,000 SIVs currently in New Jersey, waiting to be resettled. HIAS will start placing these refugees in Westchester by mid-October. The ICNAW would like to take on at least one new family this fall. To do that, we need to raise \$40K-\$50K.

The ICNAW has successfully settled three SIV Afghan families in Westchester and helped a fourth settle in Rochester, NY (with Keeping our Promise). All are financially independent and thriving.

Saving refugees is only half the job. The other half is giving them support so that they can lead a productive life. We know you give to many causes, but we urge you to donate to the ICNAW. Refugees need our help now.

Your generous gift of any size will help these families with rent, food, furniture, clothing, medical & dental care, ESL classes, finding employment and other necessities. 100% of funds go towards these refugees.


